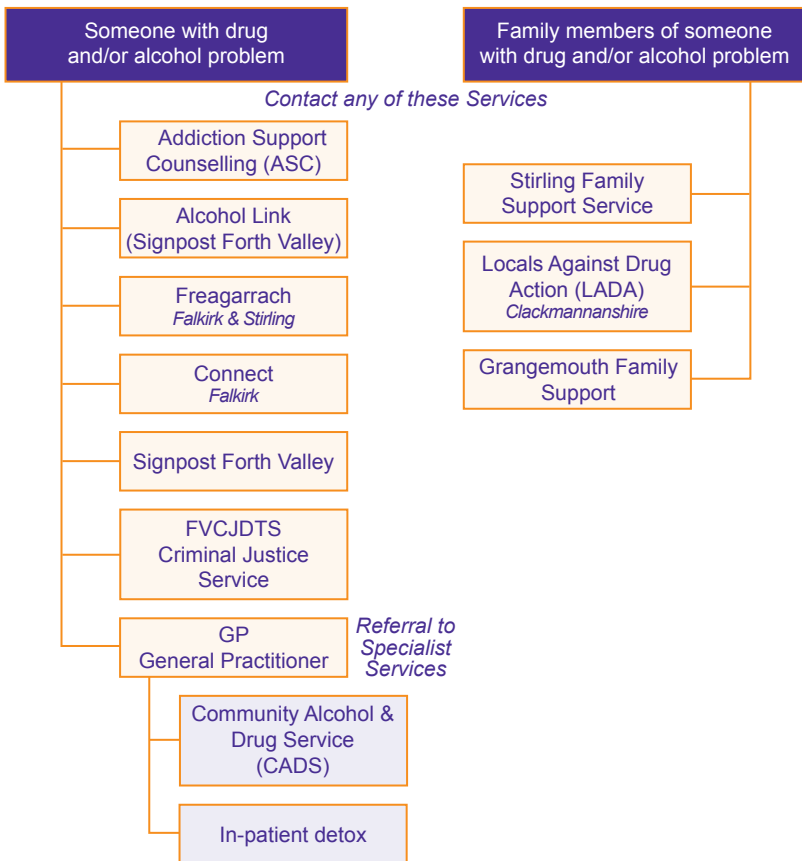

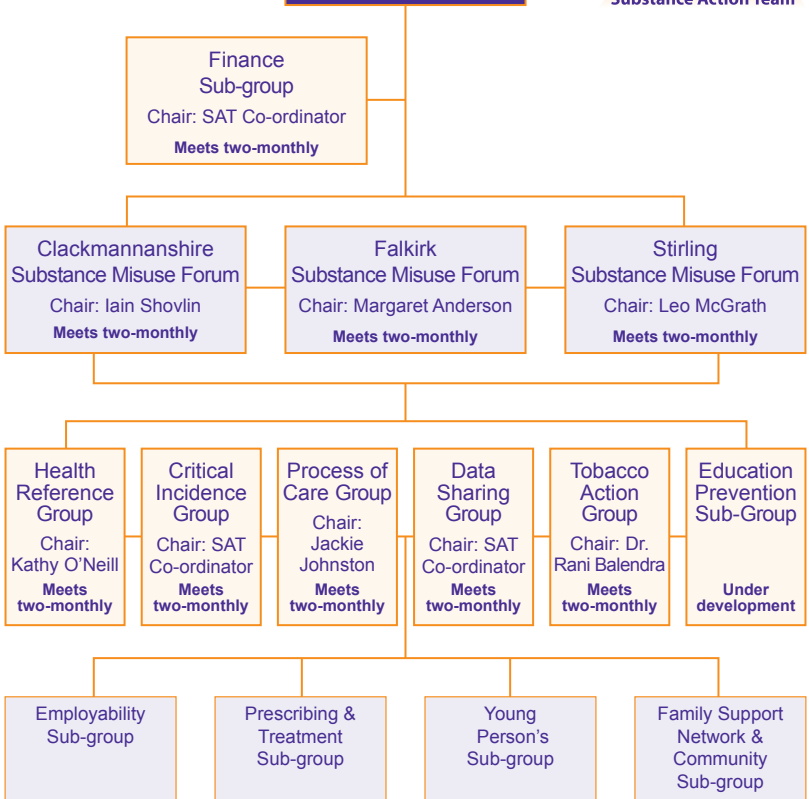

The Tiered Approach in Forth Valley



Background

Forth Valley SAT (Substance Action Team) has adopted a tiered approach to understanding and responding to the substance related problems in Forth Valley. By substances we include all illegal drugs; alcohol; tobacco; solvents & gases and those over-the-counter medicines that are commonly used inappropriately.

This approach enables **all** initiatives and services to be considered within a shared context, thereby assisting with identification of the possible gaps in provision, areas requiring development, and, consideration of the possible impact of any new development on existing provision. Our definition of services and initiatives includes education and prevention work, support services, treatment services and rehabilitation services.

The model requires each service / initiative to clarify its eligibility criteria and paths of referral. This in turn improves the writing of key outcomes for projects and aids monitoring and evaluation. It is further expected that greater consideration will be given to the training and experience required by staff, prior to appointment and during their time, with any particular service / initiative.

The emphasis of the model is on the dynamic interaction within & between the tiers and the need for movement in both directions within the model as a whole.

This document compliments the visual model depicting the Tiered Approach on page 12.

Rationale for Model

The tiered approach is designed to convey the following:

- Strategic development decisions need to be made within the context of the “whole picture”.
- Different services exist to meet the differing needs of different individuals. This is the complete opposite of the “one size fits all”.
- The Majority of individuals access / require services / initiatives / programmes at Tier One.
- Characteristics of individuals vary according to the nature of their problem/need.
- While all staff require similar skills they do not all require the same type of training.
- Interventions offered by services / initiatives vary according to the client group.
- Links between providers are as important within the Tiers as they are from one Tier to another.
- Smaller numbers of people require responses at Tiers Three and Four.
- As you move from Tier One upwards the provision becomes increasingly specialised in its use of interventions and the level of training received by staff.
- Movement within the model is in both directions.
- Any service development needs to take account of what already exists.
- Duplication of services and lack of clarity of eligibility for access is confusing and uneconomic.

This approach enables all stakeholders to

- Develop a shared understanding of the provision within Forth Valley.
- Clarify where individual services/initiatives “start” and “stop”.
- Identify detailed eligibility criteria for clients and referral agents.
- Ensure developments are additional to, but in keeping with, overall approach.
- Take account of all possible effects on existing provision in the development of new services or expansion / adaptation of existing services.
- Provide clear focused outcomes for activity in relation to the overall provision.

What does the Model cover?

Tiers

This model comprises four tiers with generic provision feeding the structure from the sides. Generic provision is not included as a specific tier because it is not accountable via the SAT for funding or development. If at any stage in the future the responsibilities of the SAT change, amendments will be made to the Tiered Approach.

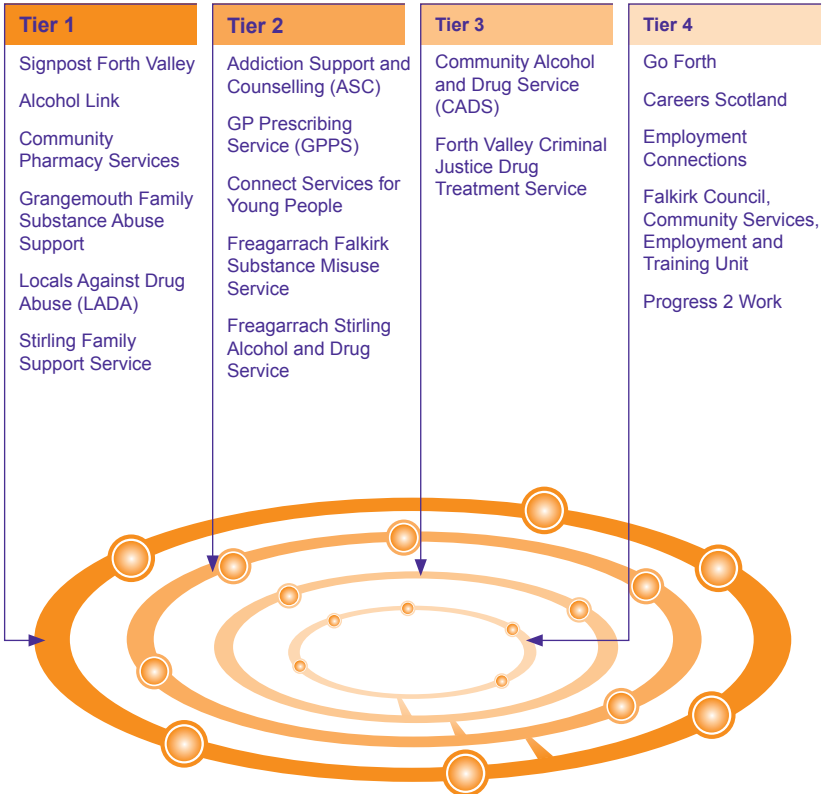
Generic provision is defined as those interventions, programmes or services directed at the whole population which are within the remit of the population to be served. Thus a G.P. appointment is generic but a specific clinic within the surgery is not. A further example would be when a school runs a substance education programme to cover all pupils and all subjects, but a specific programme targeting pupils who have been expelled, or deemed vulnerable, would not be seen as generic. The more specific the programme, and the further it is from being directly accessible, the higher the tier.

Provision will not always cleanly fit into only one Tier. There may be cases where the same provision/intervention/service would cover more than one tier. The division between the tiers is best viewed as “phased” rather than a clean break.

Ease of referral between and within the tiered model is essential to its success and as such, emphasis must be placed on clarification of eligibility criteria for access.

Figure One - Visual model of the Tiered Approach in Forth Valley

(Starting from the largest ring and working inwards)



Characteristics of each Tier:

Tier One - affects whole groups or organisations; direct access; range of access points; variable opening times; combination of drop-in and booked appointments; information & advice service; short-term focused counselling, assessment point for all other services; support services for friends, family and those who have recently completed a treatment programme; harm reduction information and needle exchange. Education and prevention work will be more targeted ie specific years rather than a leaflet / video to whole school however still likely to be large groups.

Tier Two - more likely to be professional rather than self referral; number of access points; booked appointments; medical services including community and home detoxification; mainly one to one counselling / problem solving work; when completed would refer to Tier One; unlikely that clients will have serious physical or mental health issues. Education work would be more programme based and combination of smaller groups and individual work.

Tier Three - professional referral; clients more likely to have longer history of problematic use and physical / mental health problems; less likely to be first experience of “treatment”. This Tier also includes those on the “Shared Care” Programme who are “recently stabilised and moving on to receive main support from supported G.P’s” as opposed to clinic medical staff. In-patient detoxification is also located within this tier. Education/ prevention work would more likely result from professional referral and be individual based.

Tier Four - professional and self referral; appropriate clients will in the vast majority of cases already have experience of services in other tiers; for Residential Rehab funding needs to be agreed between L.A. (Local Authority) and CADS (Community Alcohol Drug Service). This tier includes Community Rehabilitation Programmes and Residential Rehabilitation. Education and prevention work would be individualised programmes as part of an overall package of care.

Type of Provision

All forms of provision have been allocated within the tiered model. It is to be expected that some services/initiatives will further clarify their target population over time therefore the placement within a specific tier should not be viewed as permanent.

The aim is to include both specific services/programmes and short-term initiatives.

Degree of Specialisation

Services and initiatives in each Tier differ according to the characteristics of the client group served.

Therefore the interventions used at Tier Three will be more specialised than at Tier One. This has a knock on effect on the type of training required for staff and to some extent their breadth of experience.

This is also reflected in the severity of the problem and resulting complications. Individuals who remain at Tier One will have less complex drug problems than those at Tier Two or Three. Where the complexity of the problem is similar the factors indicating what service will be most appropriate will be determined by the readiness to change behaviour and previous experience of “treatment”.

Financial Information

Part of developing a comprehensive understanding of the “whole picture“ as it relates to responses to substance–related matters, is understanding the role funding plays. The source of funding, its length, how it is distributed, monitored, applied for and the number of different funding sources any one project attracts.

The support of the Substance Action Team (SAT) and preferably also of the three local forums would normally be required to enable development of Substance-related services / initiatives in Forth Valley.

Agreement to contribute details of funding to the Corporate Action Plan and the Finance Sub Group would form part of any endorsement of funding application from the SAT.

Eligibility criteria

Critical to the understanding of this approach is knowledge of which service is most appropriate for which individual. Clear eligibility criteria not only make it easier for generic staff and potential clients, it also aids those staff employed within any service to understand where their contribution “fits”. By detailing the eligibility criteria for all services, an analysis of barriers to access and gaps in provision can be identified.

Interventions Used

There are a limited number of interventions deemed effective within the substance field. The guiding principles in deciding what interventions should be made available to which clients and by what services should be based on a combination of:

- Recognised good practice
- Client need
- Service capacity
- Training & experience of staff

Referral Process

The referral process to be used by all providers is the Common Screening Assessment & Referral Form. The information on this form should be collected by the service / individual who first makes contact and then transferred in advance of the individual presenting, to the most appropriate service. Where confusion exists as to which service this might be, the form should be sent to SignPost Forth Valley.

It is to be understood that once an individual enters the Forth Valley “network of services” and an initial assessment is completed there should be no additional barriers to the individuals speedy referral to the most appropriate provider.

Training & Qualifications of Staff

The ability of staff to deliver interventions and monitor outcomes is critical to the success of any service. Linked to this is the provision of appropriate and frequent clinical and managerial supervision.

Forth Valley SAT recognise the need for on-going training and development of staff working in this field. To this end, the SAT is committed to developing and implementing a comprehensive Training Strategy. This will enable services in Forth Valley to deliver to the highest standards and develop a body of suitably trained workers. A strategy has been devised and was first implemented in September 2002. It is reviewed each year.

Monitoring & Evaluation processes

All services and initiatives covered by the Tiered Approach provide monthly updates on activity. These are published on the SAT website. For those services commissioned by the SAT or funded by one or more SAT partners quarterly reports form part of the Service Contract.

Development plans, even in their early stages, need to be included within the Work Plans of the relevant local Forum. Information from the Work Plans is combined to form the Corporate Action Plan for Forth Valley SAT. This is submitted to the Scottish Executive on an annual basis.

The success of this approach relies on all services and initiatives being able at their outset, to define their purpose, intended client group/audience and outcomes.

Each service / initiative has a distinct role to play and must be able to develop according to identified gaps. The identification of gaps relies on the provision of accurate information on current activity, hence the requirement for regular exchange of information as advocated in the Data Sharing Protocol.

How does it operate?

This approach and the physical model depicted serve to aid strategic decision-making and act as a reference point for discussions about current provision, its effectiveness and potential gaps.

On an operational level it enables those involved in delivering services to understand where and how their service inter-relates with others in Forth Valley. This will be progressed through the work of the Process of Care Group. A number of workshops have taken place to inform relevant parties as to the rationale of the Tiered Approach. These workshops will continue as part of the Training Strategy and within the SAT Annual Priorities each year.

Reviews of the Tiered Approach (both the physical model and this document) will occur at six monthly intervals to ensure it continues to take account of local development.

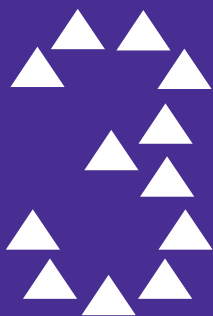

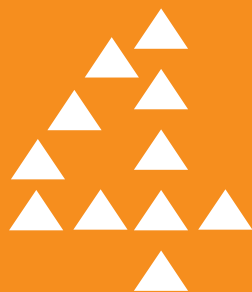

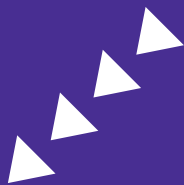
